Basic Proficiency in Medication Administration For RN and LPNs Assessment

**You have been scheduled to complete the
Basic Proficiency in Medication Administration Assessment**

- **All Experienced and Newly Licensed RN and LPNs will take the Adult version of the assessment.**
- This validated and reliable testing tool measures the knowledge and abilities necessary for registered nurses to safely administer medications to a general adult population.
- The test is computer based, 60 multiple-choice questions, with a 75-minute time allowance. The test includes three categories of questions:
 - Calculations
 - Principles of Medication Administration
 - Drug Effects
- An overall score of 80% is required for successful completion of the assessment and prior to administering medications to patients.
- If an overall score of 80% is not attained, opportunity to retake the assessment will be provided.
- Calculators may be utilized during the assessment.
